

What are the HIPAA privacy and security rules?

The HIPAA Privacy and Security Rules protect the privacy and security of individually identifiable health information. HIPAA Rules have detailed requirements regarding both privacy and security. The HIPAA Security Rule covers electronic protected health information (ePHI).

Who is covered by the HIPAA Security Rule?

The Security Rule applies to any healthcare provider, health plan, or healthcare clearinghouse that transmits health information in electronic form. Unlike the HIPAA Privacy Rule, which governs the overall protection of PHI in all formats, the Security Rule focuses solely on ePHI.

What security requirements do HIPAA covered entities need?
