

Can the Electricity Supply Act be suspended in Malaysia?

*(2) This Act shall apply throughout Malaysia; however the Minister may by order suspend the operation of the whole or any of the provisions of this Act in any State. *NOTE--The operation of the whole of the Electricity Supply Act 1990 [Act 447] is suspended in the State of Sarawak with effect from 1 September 1990--see P.U. (A) 272/1990. 2.

Who can supply electricity if he does not have a licence?

supply electricity from any installation to, or for the use of, any other person, unless he holds a licence. (2) A licence may be granted by the Commission, with the approval of the Minister, upon payment of such fees and upon such terms and conditions as appear to be requisite or expedient.

What is a power station licence?

The licence may extend to authorizing the Licencee to do all or any of the acts specified hereinafter, particularly, to lay, place, carry on or maintain transmission lines, cables or wires related to power station, in accordance with the provisions of the Enactment.

Can a licensee supply electricity to a person other than SESB?

The Licencee shall not, at any time supply electricity to any person other than SESB provided that the Commission may with the approval of the Minister in writing, permit the Licencee to distribute and supply electricity to such person.
